Article I. Object of Contract

Parts of delivery are the installation media, manuals, USB hard lock key, which will be delivered in a package and also License files, which will be delivered electronically to the e-mail address ilc@ilc.sk.

Article II. Place, Date and Method of Implementation

- 1. The place of delivery under this contract is the International Laser Center, Ilkovičova 3, 841 04 Bratislava, Slovak Republic.
- 2. Seller agrees to deliver to the buyer subject of contracts under Art. I. section 1. no later than 30 days after signing this Contract of purchase.

Integral part of the original invoice is delivery note signed by the buyer. The invoice will be paid by bank transfer in Euros.
- 5. If the invoice does not meet the requirements of the tax document, or not exposed in accordance with the contract of purchase, the buyer has the right to return it to seller for reprocessing. The new, corrected invoice is payable within 30 days of its receipt.

Article IV. Acquisition of Ownership

The buyer acquires a license to use the software package under the terms of RSoft Design Inc. license agreement once payment is received in full.

Article V. Delivery and Reception of Goods

- 1. The seller undertakes to supply the object of the contract and to deliver it to the buyer at the delivery place specified in Art. II. of contract with the delivery note.
- 2. Buyer undertakes to take the object of the contract and after receipt of invoices by post to pay the agreed price vouch.
- 3. The buyer will receive the object of the contract in one single delivery during working days.

Article Vt. Technical Support

Technical support and product upgrades are included for one year with the purchase of the software. After this period further support and upgrades may be purchased with annual maintenance contract.

Article VII. Common and Final Regulations

- 1. This Agreement shall enter into force and effect on the date it is signed by both Contracting Parties.
- 2. The buyer commits that the academic license for the university, which is the object of this contract, will be used only for research purpose and it will not be used by rem of transferred to an outside entity without the permission of RSoft Design Group Inc. in addition, no commercial development of products will be performed with this academic license.
- 3. Any amendments to this contract require the written consent of the contracting parties and shall be signed by their authorized representatives. Additions or amendments to this contract shall be effected by written amendments to this contract.
- Seller undertakes to tolerate duty of the control/audit/verification related to the contract at any time during its validity (but not more than 12 months from contract date which is the period of validity of the annual technical support) and effectiveness eligible persons which are:
